* Required number of hours relevant cabling experience: 360 hours (Open Registration), 80 hours (Restricted Registration). 'Relevant cabling experience' means experience in installing telecommunications, electrical, security system, fire system, or lift cables. Note that design or supervision of cabling work, or cabling using pre-terminated cabling such as extension leads or patching, is not accepted as relevant cabling experience.

Written proof of this experience must be supplied and can include one or more of the following:

- suitably recognised industry cabling practices (for example, licensed electrician, qualified Foxtel installer, qualified audio/ video installers)
- a statutory declaration signed by the candidate in the presence of an authorised witness setting out the details of the candidate's experience
- a detailed logbook of cabling experience showing dates and types of work
- a signed statement by an employer or a registered cabler by whom the candidate has been directly supervised detailing the candidate's experience

Section E - Additional Specialised Competencies/Endorsements:

NOTE: All cablers (including experienced cablers with Open CPR qualifications) are required to have the appropriate specialised competencies/endorsements when working on optical, co-axial, structured, underground and aerial customer cabling. All cablers with Restricted CPR qualifications are required to have a specialised competency unit when working on point-to-point data or coaxial (broadband) customer cabling.

If endorsements are not shown on your previous cabling registration, you must attach unaltered copies of all relevant original training documents as evidence of completion of endorsement courses or RPL assessment (only tick, as appropriate, below, if evidence is attached to this application).

If specialised competencies/endorsements are added after your application has been processed then an upgrade fee of \$25 applies and completion of the Upgrade/Add Competencies Form is required (unless it is done upon your next renewal with payment of the renewal fee, then no additional fee applies).
