Job Description

As the Monitoring Centre Manager, you will be responsible for overseeing the efficient and effective operations of a monitoring centre facility, contributing to ensuring the safety and security of clients through effective monitoring and response protocols.

Monitoring Centre Managers are responsible for the efficient and profitable operation of the monitoring centre and provide supervision for operators who carry out customer service, technical support and telemarketing duties. Monitoring Centre Managers may work within company monitoring centres or in independent monitoring centres that provide services to other companies. They action alarm activations in accordance with client instructions, which may include requesting other security operatives to respond to security risk situations. Much of the day to day work involves using computers that monitor alarm systems, entering data and producing reports about alarm activations.



On the Job

As a Monitoring Centre Manager, the day-to-day job responsibilities include:

- Overseeing the day-to-day operations of the monitoring centre, ensuring efficient and effective functioning.
- Managing a team of monitoring centre operators, providing leadership, guidance, and support.
- Developing and implementing operational policies, procedures, and protocols to ensure adherence to industry standards and best practices.
- Monitoring and analysing incoming data and alerts from various systems, identifying and responding to critical incidents in a timely manner.
- Coordinating with clients, vendors, and internal stakeholders to ensure seamless communication and resolution of issues.
- Conducting regular performance evaluations and provide ongoing training and development opportunities for the team.
- Maintaining and updating documentation, including incident reports, operational logs, and standard operating procedures.
- Staying updated with the latest advancements in monitoring technologies and make recommendations for process improvements and system upgrades.
- Ensuring compliance with regulatory requirements and promote a culture of safety, security, and professionalism within the monitoring centre.
