#### **Job Description**

As a Security General Manager you will plan, direct and coordinate the operations of a security organisation or business unit. Rather than focusing on one functional area of management, such as HR, procurement or administration, you will oversee all aspects of the business or business unit. You will be responsible for developing and implementing comprehensive security strategies and protocols to protect your company's assets, employees and clients.



#### On the Job

Among the day-to-day job responsibilities include:

- Oversee and manage the development and implemention of security policies, procedures and protocols to ensure the safety and protection of personnel, assets, and information.
- Develop and managing a team of security personnel, providing guidance, training and performance evaluations.
- Oversee and/or manage risk assessments and develop strategies to mitigate potential threats or vulnerabilities.
- Collaborating with your management team to ensure security measures are integrated into overall business operations.
- Be responsible for the monitoring and analysing security systems, such as access control, CCTV, and alarms, to detect and respond to any breaches or anomalies.
- Lead with knowledge of emerging security technologies and trends, identifying enhancements to existing systems as needed.
- Manage the organisations liaison with law enforcement agencies, emergency services, and security vendors to coordinate response and support.
- Manage the preparation and presention of reports on security metrics, incidents and compliance to executive management.
- Maintaining a high level of professionalism, confidentiality and ethical conduct in all security and business related matters.

## Salary & Benefits

Your starting salary can vary because of factors like employment contract, level of experience, training, or location. Your salary as a Full Time Security General manager may increase over time as you build skills, knowledge and experience.

- Qualifications at a tertiary level in business, commerce or law would be well regarded.

Your past security experience as a Security General Manager will help you stand out to an employer. Other useful skills to highlight to your employer when applying include:

- Extensive knowledge of security protocols and practices, including the ability to anticipate and respond to emerging threats in the digital and physical realms.
- Strong leadership and managerial skills to oversee a diverse team of security personnel and coordinate their efforts effectively.
- Excellent communication and interpersonal skills to liaise with internal stakeholders, such as senior executives and department heads, as well as external entities such as law enforcement agencies and security vendors.
- Proven experience in developing and implementing comprehensive security strategies and procedures that align with the organisation's objectives and mitigate potential risks.
- Proficiency in utilising advanced technologies and tools for security monitoring, threat detection, and incident response, including artificial intelligence, machine learning, and data analytics.
- In-depth understanding of regulatory compliance requirements, industry standards, and best practices related to security, privacy, and risk management.
- Strong problem-solving and decision-making abilities to assess complex situations, prioritise tasks, and make sound judgments under pressure.
- Continuous learning mindset to stay updated with the latest trends, advancements, and evolving threats in the field of security.
- Ability to collaborate with cross-functional teams, such as IT, legal, human resources, and operations, to develop integrated security solutions and ensure a cohesive approach to risk mitigation.
- Demonstrated ability to maintain confidentiality, integrity, and trust while handling sensitive information and addressing security incidents.
