## **ASIAL MONITORING CENTRE GRADING**

ASIAL has operated its highly respected monitoring centre grading scheme for alarm monitoring centres since 1990. The scheme seeks to provide customers with the reassurance that the monitoring centre operates in accordance with the Australian Standard AS2201.2 - 2004 or AS2201.2-2022 Intruder Alarm Systems – Monitoring Centres.

Among the requirements for Alarm Monitoring Centres includes (i) adherence to the National Alarm Activation Guideline developed by the National Emergency Communications Working Group which came into effect on 1 July 2019 and (ii) compliance with AS2201.2.

AS2201.2-2004 has been updated to AS2201.2-2022, currently either version of the standard can be used for certification. However after 25th March 2024 the new standard AS2201.2:2022 will be required for new or renewals of grading applications. It provides the requirements for the construction, equipment and operating procedures of a graded monitoring centre. This includes:

- the physical construction of the centre (including fire and security protection)
- ventilation systems (their integrity and operation)
- power supply arrangements (redundancy and standby times)
- communications (telephones, duress and radio)
- operations, equipment levels and staffing of the centre

ASIAL graded monitoring centres are independently audited on a regular basis.

## **ASIAL REDUNDANT CENTRE CERTIFICATION**

ASIAL's redundant centre certification scheme seeks to ensure that a Monitoring Centre's critical business functions will either (i) continue to operate in the event of a serious incident or disaster that might otherwise have interrupted the centre's operation or (ii) will be recovered to an operational state.

The certified 'Redundant Centre' is staffed and ready for operation, but there is also an option for a Redundant Centre (Not Normally staffed)' that is a secured but not a staffed location that will be occupied in the event of an emergency.

ASIAL certified redundant centres are independently audited on a regular basis.
