Assessment will be undertaken by an independent assessor as appointed by ASIAL. All certifications are nominally valid for 24 months. A prerequisite is that a current Class 5 capability certification for control equipment must be verified prior to a site inspection.

Certificates will be issued on successful completion of the installation inspection process. A written recommendation will be provided on completion of the inspection.

Any objections to the assessor's report (a copy of which will be provided to the nominated site contact) should be made in writing to ASIAL within 14 days of the date of the report. The adjudication of such objections shall be by committee as appointed from time to time by ASIAL. Any such objections do not negate the period of validity of the report.
